

# General Data Protection Regulation Annex

## Personal data processing

In accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of individuals with regard to the processing of personal data and on an unrestricted flow of such data which repeals Directive 95/46 / EC (General Data Protection Regulation) of 27 April 2016 (Journal of Laws UE L 2016, No. 119, hereinafter GDPR), we would like to inform you that:

1. The administrator of your personal data is Cracow University of Economics (Uniwersytet Ekonomiczny w Krakowie, UEK,) with its registered office in Kraków, ul. Rakowicka 27, 31-510 Kraków (hereinafter: "the Administrator").

3. Your personal data from your application form will be processed for purposes related to the organization by Cracow University of Economics of an event called GAMENET Conference which will be held on 17-21 September 2018 (hereinafter: "the Event"), as well as its documentation and promotion on the organizer's website and on their social media profiles. Your image will be processed in order to post photos in materials published in connection with the event.
4. Pursuant to GDPR Art. 6 par. 1 lit. a, your consent provides the legal grounds for data processing.
5. Your personal data may be shared with relevant recipients, in particular: the Organizing Committee, COST Association, as well as specific external entities providing IT or legal service of the administrator authorized to process personal data on the basis of a contract of entrustment or institutions authorized to review the Administrator's operations, as well as entities lawfully authorized to access such data.
6. Your personal data will be processed for a period necessary to meet the objectives for which they were collected, i.e. related to the organization of the Event by Cracow University of Economics, as well as its documentation and promotion on the organizer's websites and on their social media profiles, for a maximum of five years or until you withdraw your consent.
7. You are entitled to access your personal data, amend or delete them or restrict their processing. You are also entitled to object to their processing or their transfer in cases and according to the GDPR provisions.
8. You are entitled to withdraw your consent to the processing of personal data at any time. Data processing based on consent prior to its withdrawn remains legal.
9. Your personal data may also be processed regardless of your consent in cases of legitimate interest pursued by the administrator, e.g. claim / defence of claims (GDPR Article 6 (1) (f)).
10. Provision of personal data is voluntary. Lack of consent to provide data will render your attendance in the event impossible.
11. Your personal data will not be subject to automated decision making or profiling.
